Dated: ____ To Tenant: ____ Pursuant to California Civil Code Sections 1946 and 1946.1, a residential landlord may terminate a month-to-month lease by giving the tenant at least thirty (30) days' notice in writing, unless the tenant has resided on the property for longer than one year.
