How to fill out an LLC 1065 IRS Tax form

Single member LLCs or ones that have a single owner file a tax return using the Internal Revenue Service (IRS) Form 1040 and Schedule C. An LLC that has more than 1 owner, known as a multi-member LLC, treats their income as partnership income. These LLC forms file IRS Form 1065 and Schedule K-1.

When filing taxes, a multi-member LLC must file a Form 1065 Partnership Return. This is an informational return only, as the tax liability will pass to the individual members on their personal tax returns. Each member in a multi-member LLC is given a K-1, which provides a report on each member's profits and losses.

Q. What type of return should a single-member LLC “disregarded entity” file with Delaware? A. Delaware treats a single-member “disregarded entity” as a sole proprietorship for tax purposes. This means that the LLC itself does not pay taxes and does not have to file a return with the State of Delaware.

How to Complete and File an Amended Business Tax Return

If the LLC fails to pay the tax or file a return, you and the other owners are not personally liable. However, a drawback to corporate treatment is that business earnings are taxed twice. The first level of tax occurs when the LLC files a corporate tax return, and the second is imposed on the owners when they receive a dividend.

1. S corporation tax returns are typically due on March 15th and not on April 15th. Accordingly, S corporation shareholders should attempt to get their profit and loss statements and related information to a tax preparer in January.
